President's Comments – Kathy Watzel

I want to welcome you all to the convention. I just have a few highlights of some of the things that we've done this year. A lot of things I'm going to talk about I'm just going to touch on lightly. A lot of this you'll hear more in-depth from other people and other reports throughout the year.

As I said earlier, we have increased membership in the last six months. I did a little math and I want to tell you what it is. The membership increase since January 1 is 562 members. What you need to understand is that is the actual number. We could have lost 1,000, but then we gained 1,562. So this is an actual gain. I talked to some members earlier who said that their club does

not report the numbers on time, the batch doesn't go in on time, so their membership is defunct for 2 or 3 months and then they join, and they said so my number is in that count. No, it's not, because your number was in the count earlier and then it got added back in, so you zeroed yourself out. So that 562 are actual new increase numbers. In December of 2018 we were at 30,089 members and in June of 2019 we were at 30,651 members. So that straight across the board increase was 562. And so, then in December of 2017 we were at 30,639 and in June of 2018 we were at 30,399. So that was a negative 240 for that year, so you can see we have increase. If you compare the two together for the full increase year to year, is actually 492. Again, when you get that report, it's a little different because of what they're comparing.

I did an extensive look, and many of you have heard this, after our last meeting on the Bulletin costs because Peter brought it to our attention (Peter from Cypress Cove) that that was where we could cut money. We heard strongly from people in the membership and on the committees that they didn't want to get rid of the Bulletin. We are not getting rid of the printed Bulletin. You have the option to opt in, you just need to let us know. So please let your members know if they aren't getting their Bulletin, and usually that's how the office hears. "I didn't get my Bulletin" well, just give us your email and you will receive it or if you still want it mailed, we will mail it to you.

It was very interesting on the costs, I mentioned it a little bit at the meeting the other day, that if you are a Canadian member and you are an individual, we are actually losing about \$6 a year for you being a member because of the postage and the printing costs and that. So that is something we need to address and look at.

I did mention earlier, too, that I had a meeting with the office staff on cost saving ways, what they could brainstorm and come up with how we could save money. So, we are all very aware and we are trying to do a very good job at saving the dollars for AANR.

One of our biggest programs that we are instituting this year is Impexium. That's the new computer system going in at the office. And we had multiple meetings with them by phone to talk about the program before we signed the contract. Erich and I talked to them on the phone. We had a wonderful conversation with the president of the company that was, in my opinion, semi-humorously after it occurred because he kept telling me "no", he wasn't going to do the things I was asking him to do in the contract language. Some of you know I negotiated contracts for over 30 years for teachers. And so, after the phone call was done with him, we brainstormed, and we took our position on where we were going to stand with the company. We got an email back within a week and he gave us everything we had asked for. That doesn't happen in teacher negotiations. I was blown away. So that was just simple contract language changes that Erich took care of. That is going very well at the office. We hope that they will both be going side by side, the old system and the new, in October. And then we hope it will be very smooth and we won't have any bumps or nicks. Erich's going to talk about Impexium a lot more later on.

One of the other things that many of you are not aware of, and I will have these at the back table for you later some of you when I came to your regions I showed you and talked about it, is this brochure that Karen Lahey, Erich, myself and people in the office put together. And this was for the World Naked Bike Ride. This is something we are offering to all regions or all clubs. We will do the print and the artwork for you for a public pamphlet to hand out at some organization. Then we will send it digitally to you and you can print it and use it. It's a very professional looking piece. This was done for the Northwest. If you have a naked bike ride in the West or the East, we will take the page that talks about all the clubs in your region and change it. The rest of the information can stay the same. We can do it for any event. Volleyball, swimming meets, topless

events, whatever. One thing that we are trying to gear these to is events where people want to be nude. Your success is going to be so much greater. I have a great story that came out of the Northwest when I was there and I don't remember the gentleman or his club, but it was after the World Naked Bike Ride and he reported out that they had gotten six new visitors since the event of the World Naked Bike Ride that had occurred two weeks earlier. And I said, if you got six people from an event that occurred two weeks ago that you handed these out at, that is 100% success. And he was very surprised. We had two billboards up at MAR for two years and not one person put down they saw the billboard as they were driving down the highway.

Another thing we are doing is "you have been patronized by a nudist." We're going to put that on the website so you can go in, pull it off, you've got it ready to go, you can put something on the back and print it off. So, these are services we're trying to offer to everybody over the last year. Another thing we talked about, and I know the regions have talked about it a little, is a passport system. Two of the regions already have it and we're looking for everyone. That has a lot more glitches and nicks on how to do it and how to do it all on the computer and have it work successfully. But these are just a few of the things we have been discussing over the last year to make the Association better and work for you.

Another piece that you may have seen in the Bulletin is the column that Erich is now doing telling you what's occurring in every region every month. Many of you, and I know I wasn't aware of this, don't know they handle two to three calls a day on issues with nudity. It's probably a quiet week when you only have two phone calls. And Carolyn keeps a log on all of those on what's going on. Unfortunately, because of legal reasons, they are unable to let you know specifics on a lot of that. And Erich hopes that in the future, as some of those cases quiet down, he can get more specific and inform you on what's going on.

I hope that gives you a little insight into what we've been doing this year. Please let us know if you have any ideas on how we can do a better job for your regions or for you personally. Thank you.

Executive Director's Comments – Erich Schuttauf

I want to begin by again thanking Sun Meadow for an absolutely incredible job of putting on the Convention that we have here. Can we thank them again [applause]? As already announced, it happens because of a little help, a lot of help, from their friends. A lot of people who have been staying up late to vacuum floors, getting our breakfast, and sometimes when some of us don't show up flor meals, we mess things up as well. So, the patience that is shown by the volunteers that are here is so deeply appreciated.

If you were here last night for the musical presentation that was done by McLeod9, an absolutely incredible performance, and I wanted to start by talking about it because the most incredibly magical thing happened if you were there for that performance because there's a crowd around and they're playing this music and they're playing the violin and other instruments, mandolins and everything. And you've seen, I'm sure, this little 18-month old girl that is with her folks here, Julia. And so, the violin is playing softly, and this girl walks up to the stage and she is just swaying to the music, swaying as they are playing it. And then, other people get up to dance. And I don't single them out, but Jan and Stan Ricks get up and it is this most romantic moment, frankly. And in back there is this sign that says, "nude family fun in the Northwest". And I said that is why I love my job, frankly. That's why I love you

being here. That is why you love AANR for moments like this, whether you're 18 months old or eighty, there's a place for you in nude recreation.

Now the sad news is a bit of what Kathy touched on, is that regrettably it isn't always happy moments because there are families that are having the custody of their children questioned. Last week I had to talk to Arkansas state lawmakers about this law that's been on the books for years, but I also had to tell them about a situation where a couple in Arkansas was denied adoption. They were told by the adoption agency "you're nudists, you're AANR members, and you can't adopt". Now we are working our way through the agency. The folks involved did not want to bring a lawsuit, they wanted us to inform lawmakers of this problem and they're pursuing some other avenues. But we get those calls, as Kathy said, on a regular basis and we do keep a log of each and every family, each and every person who has lost a job because they enjoy nude recreation, everyone who has been cited for being in their backyard and if I could give you a short message on Government Affairs it would be this. The battle has shifted from the United States Congress and the states. You have done your job well with the National Conference of State Legislators. We do have issues that happen occasionally, but that isn't where we're seeing the battle anymore. The battle is in your backyard. Because even if you have a fenced backyard, there are neighbors who like to call the police knowing that you're out there and knowing they might get a leg up on the naked person next door. And you would say "how can they make an issue out of somebody behind a six-foot fence in their backyard". Folks, I had four cases this year. Four different cases, including one that's going to a Court of Appeals in Virginia. Because the neighbor knew they were outside naked and if they called the police and they responded, they would find a naked person in the backyard and then they could make something of it. Did these battles always start with nudity? They might not. They might be over the way that somebody keeps a dog in the backyard that barks and starts a dispute. It might be a custody dispute that spirals into nudism, but they try to use it against you. And I have to be honest, I wouldn't be straight if I didn't tell you that families call us that have their custody in question. And so this is what AANR is doing day in, day out and the Government Affairs Team that meets each month to discuss what is happening in areas where they're cracking down on nudity or seem to be telegraphing they are and then we put the fire out, as happened in Utah. So, please keep on keeping on. If you can take any message back to folks, take this that AANR is still on the vanguard, along with its regions, of protecting your right to enjoy nude recreation.

And that's number one on that mission statement that Joan talked about yesterday so well. So, we protect. But then we also promote. And I'm in a difficult position because of I don't want to steal thunder from awards that are going to go out on media in just a few minutes. But we may interject from time to time about what the value is of getting the message out to the public about nude recreation that these various news articles you're going to hear about, these various television programs, are getting the word out about nude recreation, what they're worth in promotion. As soon as I saw the list that Joan had prepared, "Protect, Promote, Provide, Preserve", the first thing that occurred to me was that you can't spell any of those words without "pr" in the front. You've got to have PR. Even in Government Affairs we have to support those efforts. We get good press, we talk to lawmakers; we get bad press, we apologize to lawmakers. They go hand in hand. You can't do those two things without PR. And providing what's a part of what's being provided here. Hopefully over the course, you will learn some things. Shirley yesterday and Tim were excellent about talking about how you can help Government Affairs without a \$50,000 check.

Tomorrow we will have things on social media, and I think you will want to be present to learn how to enter the Twitterverse and Facebook. Kathy will tell you firsthand that we went to these various social

media companies on your behalf and said "Look. You are really pressing our clubs because they can't get a simple message out about walking nude down the beach or visiting them for a music festival if they show any skin and you shut them down and put them in Facebook Jail. I can't tell you we've turned that overnight. But tomorrow we will share some of the things that their head of government relations told us to do or not do so we can keep communications channels open. Your dues made it possible for us to have a face-to-face meeting with Facebook and the President of your association about social media.

There's a club on the east coast that was turned down for a merchant account because they're a nudist club. They were turned down by a well-known bank, Wells Fargo. And at that National Conference of State Legislators we were able to meet face-to-face with the senior vice president of government relations for Wells Fargo. Both myself and Larry Deschênes, who's in the back who'll tell you his own personal story face-to-face, Kathy felt it would triple-team them if she also went over, but the point is that on the corporate level it's a miscommunication that needs to be worked out. We couldn't reach the right levels on the east coast, but perhaps somebody working out of the Arizona office in senior government affairs can help us. So, we try some different things and your dues make it possible to have a one-on-one meeting with the President of your association and a high-ranking representative of Wells Fargo and Facebook.

I hope you take back those examples of how we are protecting, how we are promoting. We are providing the experience through Sun Meadow and the help from their friends, and preserving it. Because I tell you one day that little girl is going to be applying for a scholarship. We heard last night about a young lady who got a college scholarship, several of them, and now her folks are helping to organize a fundraiser for the Education Foundation. That's preserving what people are going to enjoy in the future.

My son is now serving his country in the United States Army and one of his first experiences and friendships he made was over nude recreation. I told this story in a few places and I'm going to close with this. He's in basic training and studying to be a soldier and what do they do? They carry firearms and shoot at the range, they throw hand grenades, all of these things. The soldiers aren't afraid of those things or a ten-mile rucksack, with the things on their back. They are, however, afraid of stripping off and going into the shower at the barracks. That's what these young men were afraid of. So, my son throws his towel over his shoulder and walks right on into the shower. They said "Man, you aren't bashful, are you." He said, "I grew up as a nudist." And out pipes, in this small group of 25 soldiers in this squad, one who said, "My grandfather had a place at something called Cypress Cove in Florida and I used to go visit him a lot". And they became barracks buddies or battle buddies through the course of basic training. What were the odds the 25 soldiers would have two nude recreationists among them? But that's a true story. That is worth preserving, what you gave to my family. And what AANR gives back to you and to your extended family, your friends.

We'll give you specifics on Impexium a little later in a segment, and we'll have a little bit of a handout for you and take some questions on Impexium.

Special GAT Award – Erich Schuttauf

Actually, Madam President, with your indulgence, we have two matters. Delighted to be doing this. One of our regions has requested an opportunity to just recognize a person in their region who has made some outstanding efforts in preserving beaches in Florida this year. And by doing this we get it in the record. I understand it's not in the official award nominations, but at the same time it is very much deserving of a place in the record. I'm going to ask Ralph Collinson to come forward if he'd be willing to. The region that Ralph is in, AANR Florida, has asked that we recognize their Government Affairs professional, Ramon Maury, who has been working for the Blind Creek Beach among other efforts. Ramon is there in Tallahassee each year for visits but is also working on preserving Blind Creek Beach which has been there in St. Lucie County for the last two or three years. In particular there have been some issues. I'm going to get the plaque ready, if you want to say a few words or anything else you want on the record.

[Ralph Collinson] Maybe give you a little background. There's been some misinformation sent out by certain individuals about what's going on in Florida. Blind Creek Beach did have a threat of sorts. There are some wealthy people in that county that are horse people who were eyeing the nude beach. They actually got permission a year or two ago to build some horse trails in that area and they really wanted the beach. But they were very disorganized. And the big thing was the nudists were organized and we've proven to the county that we bring a lot of money into that county with vacations and such. Recently Ramon and Erich wrote language that we provided to the county that they can use to designate this a nudist beach. That was Phase I.

Phase II, we're now trying to get a nudist beach on the west coast of Florida in a state park. Historically in Florida there were about ten nudist beaches on state park property back in the 60s and 70s and they're all gone because the state parks passed a rule in the 80s to ban nude swimming. Working to get around this regulation, Ramon is going to be the person doing that. And we've had a lot of good cooperation. TNS has donated for the Blind Creek effort. South Florida Free Beaches are donating for the Phase II effort and we now have a user group that's called "Tampa Bay Free Beaches". We had a user group there for a long time who were AANR members, but they were pretty ineffective. They did get petition through and we had 14,000 signatures on the petition which is sufficient to bring it to the state's attention. They did at least that part. This new group seems to have their act together maybe a little bit better. They're now an AANR club and have donated to AANR. And we have, also, a new landed club, "Eden RV", which is in that same area. Seems to be some momentum now to get a beach in the Tampa/St Pete area. So, Ramon's going to be working on that also and he does a lot of other things, too, throughout the year.

[Erich] We have tried to prepare a fitting memento or token to thank him for the work he's doing and know that at a future AANR Florida meeting it can be presented as well but appreciate the chance to put that on the record.

[Ralph] If you were on the cruise this year, you might have met Ramon. He got a free cruise from the cruise company. He's probably one of the few lobbyists in the United States that is a nudist.

Non-Nudist Newspaper Article – addendum, Erich Schuttauf

You may have heard, when they handed a small piece of walnut out that there was an award for an article in the New York Times. The name of that article was "And the Bride Wore, Um, Nothing (the Groom, Too)" and it was about nude weddings that took place in several clubs across the United States. The small piece of walnut you saw is going to the writer to thank the writer for a great article. We have a little bit something special prepared for the clubs that were involved in this article because they come from three different regions. That does not usually happen when we have press it's typically one place or the reporter might visit a couple of clubs in, say Palm Springs. But it is rare that we get something that reports on so many clubs in different places.

I want to talk to you about the value of PR, because we're going to show you in 3-D form just how large this article was within the New York Times. This particular article, we shopped the rate card and said if you were going to get an article of this size, with color, all contiguous where it doesn't go from one page to the next page, what would it cost to get that placed. And on any day in the New York Times it's at least six figures. You're talking at least \$100,000 and on the right day and section, it can approach a half a million for this much ink in the New York Times. That's what we celebrate. That's why you're here, too, to celebrate the success that your association makes possible to get the word out. We have a plaque prepared for each of the clubs and I want you take a look at this. This is exactly how it was prepared...continuous ink in the New York Times, this is color photography on Sunday, February 24, 2019. And again, we're talking depending on what your frequency advertising is, anywhere from a hundred thousand to a quarter of a million dollars to get that much ink in the New York Times.

This was worthy of celebrating, so we took a few liberties to mention, to prepare a custom little plaque for each of the three clubs that were named in this article. So, you have Green Valley, from the Midwest (Ohio); we had Cypress Cove, from Florida; and we had Wildwood from Texas (Southwest). We didn't bring all of these out here because they are glass and break easily, but we had them made for each of the clubs. We hope the clubs will put them on the wall in a major place to show what we're celebrating, but also that it came from your Association. That was Kathy's suggestion that we point out it is recognition from AANR.

There's a fourth one of these plaques that was prepared, and I want to say why. Because instrumental in getting this article into the New York Times and instrumental in conducting numerous weddings and nuptials for persons of both straight, lesbian/gay couples, folks from all faiths, Carolyn Hawkins has been there to provide wedding services to people, interfacing with those folks and I had a number of people whisper in my ear "don't you hand out a piece of walnut if you don't give one to Carolyn Hawkins of your staff who did so much to make this happen". One has been made and will be going to her.
