Education Foundation – Margie Cantlon

- ➤ Has been working hard on scholarships. There are 3 a year, a \$1500, a \$1000 and a \$500. This year Carol Carson from Land O' Lakes Florida passed away and left the Education Foundation \$10,000. This year there were so many extraordinary applications we granted an extra \$500 scholarship. Also, we did a special scholarship to a lady at Cypress Cove who is a PhD in audiology and wants another PhD to go into research. To fund this special scholarship, Sun Meadow dedicated the proceeds of their Poker Run to the \$1,000 scholarship plus 3 members of the scholarship committee donated \$40 each to reach the \$1,000. The next day an email was received from a guy saying he was so moved by the passion about the scholarships that he donated \$1000 to the Foundation.
- There are 3 pieces of artwork that will be raffled online. The website is being developed. Two years ago two or three of the grant recipients were artists and part of the stipulation was they had to give us a piece of art.

We move that AANR uses the modified AANR-NW Non-Discrimination Policy (as shown below) for AANR and that any club agreeing with the statement be listed with the statement on a tile aanr.com.

AANR reaffirms its non-discrimination policy by-laws, Section 1 Article IV A, "AANR welcomes all people willing to conform to its principles and standards, regardless of age, gender, marital status, religious beliefs, ethnic origin or sexual orientation."

This includes welcoming all single, partnered, and married people of all gender identities, ethnicities, sexual identities, ages, sizes, religions and physical abilities, attributes and body decorations.

Purpose: To clarify the definition of AANR's non-discrimination policy and to make it

easier for all people to find clubs where they are welcome.

To ensure that clubs would want to use this functionality, we have contacted a few clubs in each of the regions and the following have agreed to be listed with this statement: Bluebonnet (Southwest), Cedar Trails (Midwest), Dyer Woods (East), Laguna del Sol (West), MARNA (East),

Mira Vista (West), Oaklake Trails (Southwest), SLUGS(Northwest), Solair (East), Southern California Naturist Association (West), Sun Meadow Resort (Northwest), Willamettans (Northwest). These clubs represent many regions, are big and small, owned and cooperative, destination clubs and travel clubs. (Florida region and its clubs are endorsing an inclusion and non-discrimination statement of its own.)

to this statement. For instance, they are a 21 and up club and support AANR's principles and standards. They are not a swinger club but have legitimate business reasons for not admitting children. This is one

example. There also is no enforcement ability on AANR's part. A person can go to Impexium to discover a club's policies as well as amenities. This would be a better way to communicate the policies and restrictions of the

club. A club could also put it on their website.
