Presidents Report December 2021 Kathy Watzel

Over the past months the office staff has continued to work on two large projects, Impexium and the new AANR web site. Both have their challenges. The office staff continues to use Impexium, working to improve its functions for our organization. The seven regions with differing dues structures are a challenge as well as the Canadian and the US currencies. We continue to work with Impexium to improve the programs usage for AANR while maintaining dual use with Connetics. Until Impexium is functioning as outlined in the contract the staff will not sign off on our first years financial commitment.

Our new content and visually rich website has been live since November 2021. The new web site doesn't just have a brand new look, it allows us the ability to add new content daily keeping the site fresh and a place members and guests will want to visit over and over again. We will be constantly updating our content with helpful information and links to other nudists articles. Our goal with this new website is to provide our visitors an easier way to learn about AANR. We hope you find the new website, with a fresh look, easy to navigate and access information while establishing this portal as a source of information for those who visit our site.

Our membership has begun to decrease over the month of December, this is a normal pattern for our organization during this time of the year. AANR's membership is still higher than it was at this time in 2020. Our membership numbers continue to be encouraging and we believe our numbers will continue to grow in 2022. Due to many factors, the increase in membership over 2021, separating couples to individuals, an increase in dues, and the Bulletin being delivered to the majority of our membership via email, our financial position remains strong.

We continue to help our members with legal issues. Over the past six months the AANR staff has assisted many with legal issues. The most interesting case was dismissed because the individual is a member of AANR. This is a very exciting message that will be shared with our members in a future Bulletin article. Membership in AANR is important and of value.

Our 90th year has come to an end, and we have begun to plan for our 100th year celebration. We are encouraging all regions to begin planning for our celebration in 2031. Over the next nine years AANR needs to plan for a spectacular celebration.

As our organization moves forward, into 2022, we will continue working on the health and wellness project promoting a stronger membership, improving the Passport program, support our clubs and developing revenue streams through new fundraising programs. A word about AANR's Mission...

The AANR Bulletin often includes the AANR Mission statement, but it bears repeating here:

AANR exists to protect, promote, provide, and preserve nude recreation by:

- Protecting nudists and naturists from policies at the local, state and federal levels that interfere with the right to enjoy clothing-free recreation in appropriate settings;
- Promoting nude recreation by educating government leaders, employers and the public;
- Providing support services and community to our members;
- Preserving the financial viability, integrity and strength of the AANR organization.

This report is framed with that mission in mind.


Member Community - Leadership Survey Distributed

As this report is being prepared, AANR has sent an electronic survey to the leadership (Officers, Trustees, and Region Presidents) to address a variety of topics, including diversity, attracting new members, and much more. After reviewing initial results, the survey is next planned for additional region leadership and committees. The information obtained will enable decision-makers to build member community, reach out, and enhance the welcome extended to those who express interest in what we enjoy.

Promoting Nude Recreation - All-new AANR.com website now online.

During Thanksgiving week, (November 2021) an all-new AANR.com website made its debut. Among the key changes is new content about people sharing why they enjoy nude recreation, a forum for information on public lands, a portal into the Impexium system, and encouragement to join Naturist Hub

for communication with other nudists. We appreciate feedback from AANR's members and leadership as we improve the site and continue to deliver new content.



Promoting Nude Recreation – 2021 Photography Project

Speaking of website and other promotional developments, AANR listened carefully when clubs and regions expressed the need for a greater library of images depicting nude recreation for people from all walks of life of every shape and size. Specifically, AANR enlisted the help of eight photographers and nearly two dozen members who agreed to appear nude in images contributing to the project.

AANR is especially grateful to Cypress Cove Resort and Spa, to owners Barbara Hadley, Ted Hadley, and General Manager Peter Sewell who arranged to waive grounds fees and make meals available for all volunteers. (Ted even posed for an image or two!) Collectively, the contributors to this project made it possible to assemble more than 600 images depicting a wide range of activities and body types in varying stages of nudity.

The photos celebrate all abilities. Most are photographed in "generic" settings such as an RV site or "walk in the woods" indicative of any nude experience so that they may be used to promote venues as needed. These images are high in resolution, generally in the 6-7 mega pixel range or greater. Photo releases are maintained on file as well. This library will be made available to club and region leadership as one more tool for promoting nude recreation.

Promoting Nude Recreation and Celebrating Strength Preserved - 90th AANRversary Continues Over the summer a number of 90th AANRversary events commemorating this milestone took place including birthday parties with cakes, service projects (planting 90 flowers or donating 90 items to a charity), as well as photo opportunities (e.g. 90 people in the pool, spelling out "90" with people, etc.). Star Ranch in McDade, TX, host of the 2021 AANR Convention, held a large party with live band. Photos appeared in the convention issue of *The Bulletin*. Continuing this theme through Fall and Winter, *The Bulletin* ran stories about decades of history, and members who were born in the same year as AANR (and its predecessor the ASA). Also included were stories on those holding longest continuous membership, or with interesting stories to share such as multi-generations of nudists in a family.

Promoting Nude Recreation in Media – *The Street* and *Essence* reruns the Black Naturists Article

The Street serves as an online resource on all manner of business-related topics and is read each week by millions of web visitors. In November, 2021 *The Street* carried a story entitled Retiring to a Nudist Community with quotes from AANR Executive Director Erich Schuttauf. It was made possible with additional information supplied by Cypress Cove and through extensive work pitching and facilitating the story by Mary Jane Kolassa, PR Consultant. The website even included a short promotional video with text. Essence magazine online issued an encore version of the success of the Black Naturists club. See, e.g.

Looking Ahead...

Finding Community at the AANR Convention at Suwannee Valley Resort in August 2022

AANR Convention Comes to Florida in August 2022. The staff and leadership of AANR are delighted to be going to White Springs, Florida *next* summer for the 2022 Convention at Suwannee Valley Resort. SVR remains a leader and has been the fastest-growing club for the past several years. BG and Tom do an incredible job, as anyone who has visited will attest. The live bands are strictly top-shelf as well.

Membership Initiatives

AANR Membership *grew* by 849 members (3.11%) over the year-end 2020 count as of October, 2021. This is significant given the ongoing effects of the pandemic on the public's traveling plans. Several initiatives helped contribute to this growth.

Health and Wellness Calling Project and New Member Welcome Projects. Beginning in winter of 2020 in response to health and travel conditions and at the suggestion of President Kathy Watzel, AANR staff began telephoning (and where applicable, in follow-up emails) to direct members of the association who had not renewed after being sent the customary notices by mail (i.e. after about two months). AANR staff tracked these communications. As of this report, more than 3,750 communications and updates to records have been made within the past 21 months. Meanwhile, AANR has made a significant effort to welcome new direct members with custom messaging and surveys after three months (approximately 500 members.)

Impexium System Serving Members, Clubs, Staff, Committees. AANR continues implementing and training Certifying Officers (C/O's) of clubs on the all-new customer management system to facilitate membership information, sales, and empower club C/O's to make changes reflecting member preferences, club policies, rosters of membership, and much more. Electronic payment systems via credit card or electronic check are available for convenience. Region, leadership, and committee tools are also features of this system. AANR Trustee Karen Lahey has been instrumental in developing new member applications and services that are distributed through this system.

Member Community - AANR Passport Program Awards Prizes

More than two dozen AANR members were recognized for their participation in the launch of AANR's Electronic Passport program to recognize visitors.

Protecting Nudists and Naturists With Government Affairs and Legal Efforts

National Conference of State Legislatures (NCSL) in November 2021. In response to health restrictions, NCSL was postponed from the regularly scheduled conference until November, 2021 and was moved from Chicago to Tampa, Florida. In particular, creation of new clothing optional beaches, and discussing Little Beach, Maui Hawaii were key topics. AANR President Kathy Watzel traveled to Florida from Colorado to attend this event, as did BG Parkes of Suwannee Valley Resort, and Jack and Mary Anne of Tampa Bay Free Beaches. A large delegation representing Puerto Rico made it possible to provide additional contact information to AANR Florida's Puerto Rico and Caribbean team.

Florida Legislative and DEP Agency Developments. AANR Executive Director and General Counsel has agreed to serve as *pro bono* counsel on a legal team effort to change the Florida Department of Environmental Protection's "swimsuit rule." The team includes a number of clubs that have signed on in support, and the Beaches Foundation, and prominent past political leaders in the state.

Hawaii Clothes-Free Beaches Threatened... Nudists and Naturists throughout the continent are lending support to efforts to preserve Little Beach on Maui. As this report was being prepared, AANR had arranged a donation to the Friends of Little Beach legal effort prior to the close of 2021 from the AANR budget. Additional funds are planned in 2022.

New Government Affairs Fundraising Project – 2022 Kicks off with a great contest and fund-raising opportunity courtesy of AANR East President Bob Roche and White Tail Resort in Ivor, Virginia. Entry / Donation Forms appear on the back cover of the January 2022 issue of The Bulletin and will run in future months. This is an opportune moment to thank AANR SW President Mitch London for his contribution of a hand-crafted Nude-Opoloy game which generated a very strong response through the close of 2021.Congratulations to contest winner and Premier Member Andy Karlic of New York on being drawn for this prize!

Canadian Developments – AANR now tracks activity through the Fiscal Note program. GAT welcomes Gregory Hastings of the team who regularly reports with updates as well. This year Fiscal Note demonstrated that it was flagging several regulations addressing nudity in establishments licensed to sell alcohol (it largely applied in Quebec rather than in AANR Western Canada provinces. The system also helped AANR identify a declaration by the Canadian government that a number of Picasso's nude paintings had *significant cultural value* to Canada so as to exempt those works from "red tape" associated with transporting them across political boundaries. Such recognition of the cultural value of nude artwork may prove quite useful in the future when community-standards based legislation arises.

AANR Helping Members and Clubs – As occurs from year to year, AANR received several requests for information and assistance related to citations received for nudity. (We recently apprised a board-certified attorney about the legal status of various nude beaches, for example.) We also assisted a member with solutions when a neighbor complained that they could see into the member's fenced back yard where informal nude events with a small group of friends took place. Finally, a government employee of many years was threatened with job loss after the employer learned of their participation in nude recreation and travel. We are working very closely with this member and their spouse and their attorney on the response such as providing detailed case precedents. As a regular measure, AANR's Government Affairs Team tracks 50 state legislation including Puerto Rico, Canadian provinces, and some regulatory bulletins through software subscriptions. This allows us to spot trends.

Here are some of the specific actions over the past six months. Names and identifying information are redacted for confidentiality reasons. Note that many situations require follow up over a course of several weeks or months; issues where a new jurisdiction becomes involved (e.g. from criminal to civil court) are given a separate entry below:

July 2021

• Continued guidance provided to a member who is employed in federal government service and the member's legal team after a promotion and transfer were "derailed" when the government employer learned of nudist affiliation and activity;

• Provided guidance to a member in the SouthWest who was reported to child protection authorities by an ex-spouse who learned that the member, their current spouse, and 5 children live and recreate in the nude. Worked with the member's attorney to prepare for proceedings;

August 2021

- Provided information to a member in the East with a medical condition that regularly makes nude recreation in their home and club setting awkward on occasions;
- Continued follow up with a member in the upper Midwest reported for being nude in their own home and on property by a delivery driver. The member was spared adjudication after consulting counsel that AANR had put the member in touch with through a referral. (To date there are no plans to proceed with formal charges but the case must be monitored to ensure this remains so);
- Responded to a West coast individual's request for basic information on state statutory and case law considerations on the subject of nudity on beach(es) and private property;
- Provided guidance to a member in AANR East on the subject of nudist parenting in yet another case where an angry ex-spouse was involved;
- Contacted the legal team representing several defendants in the Nirvana rock band's famed naked album cover case, providing possible resources and citations;

September 2021

- Participated in Florida Recreation and Parks Association (FRPA)'s conference on the subject of the legality and custom of nude use on Florida beaches;
- Responded to a request from a club in the East on matters of admissions, guest comfort, and security;
- Assisted a longtime AANR member-couple in the Midwest with end of life issues when their home health provider refused to attend to the couple unless they remained fully dressed. AANR worked to educate the provider about how deeply important nudity is to those who have practiced it nearly life-long, as well as offering to put them in touch with other health care providers who have made arrangements with nudists workable for staff, etc.
- AANR fielded communications from the spouse of an individual in the Midwest charged over nude photographs;
- Assisted an AANR member couple in the Northwest after an ex-spouse complained that *other* members of the family had attended nudist clubs even though the child of the complaining spouse had never visited;

- Assisted with basic information and guidance to a Florida member---including referral information-- concerning lease in a home in a non-AANR (but formerly nudist) resort;
- Assisted a prospective nudist business owner in the SouthWest with information concerning viability and legitimacy of the nudist market;
- Answered questions for AANR members in the West concerning privacy issues, employment inquiries, etc. when persons hold membership in a nudist organization;
- Fielded calls from a concerned member in the NorthEast cited for nudity under an obscure law dating to the 1800's over being nude with his dog on his boat on a remote waterway. (AANR assistance equipped the member's attorney with information and the member successfully defended the charge. AANR *membership* actually helped establish in court that their nudity was not prompted by improper intentions!)

November 2021

- Responded to a request for information from a Floridian concerning discreet nudity on waterways. The individual and his spouse have a family with five children who simply enjoy boating *au naturale* on occasion;
- Responded to a request from an attorney in the upper Northwest who is providing representation in a "high profile" nudist custody case. It involves a former law enforcement employee;
- Responded to requests for information from a person in the SouthWest seeking possible options after the person's Homeowner's Association complained about partial nudity viewed, resulting in a ban from HOA facilities;

December 2021

- Responded to two separate Homeowner Association issues from two AANR members that involved nudity, but were *different* from the incident described in the November 2021 entries;
- Provided guidance to an attorney representing an AANR member in the Northeast in parental / custodial proceedings where participation in nude recreation has been made an issue. Provided detailed case law, statute, and other resources with possible testimony for online hearings in the future.

(Information from my report previously provided in August 2021 about AANR helping members in the January – June, 2021 time frame appears below):

January 2021

• Guidance provided to a club on handling a complaint about alleged harassment of a guest by another guest;

- Assisted an *adult* AANR member in the South who is advanced in age and whose adult child was questioning the member's decision to live within a nudist park; provided ample information to the member's attorney so that they could prepare for competency hearing(s);
- Assisted AANR members "chased off" (but not cited) from a traditional (albeit unofficial) nude beach in Florida by a representative of a county sheriff; provided legal guidance to the members and the sheriff's office on the proper application of state law;
- Provided guidance to club concerning background check procedures being used by that club;
- Provided guidance to an AANR member who lives upon a state line and who holds informal skinny dip events within the member's backyard and which draw persons from both states; discussed a variety of issues when a neighbor began building a treehouse that would overlook the property. Issues included consideration of Homeowner Association procedures/policies; tips for addressing conversations with the neighbor, as well as preparing for conversations with law enforcement should they occur;

February 2021

- Discussed legal implications/strategies with an AANR member for starting a non-landed nudist club within a state with a legislative history that is hostile to public nudity;
- Provided a "survey" of statutes and case law to an AANR member researching ordinances regulating nudity where alcohol is sold or served; identified key patterns in these laws;

March 2021

- Addressed questions concerning non-club members who attend club events and use club facilities;
- Assisted an AANR member denied financing/loan modification on the basis that the member's home is located on the grounds of a nudist club; helped the member secure financing through alternate channels;
- Assisted with diffusing *criminal* charges alleged (but eventually not pursued) in the adult guardianship case described in the January 2021 section above;
- Responded to alleged defamation claim related to a member's conduct during a visit to a Northern club;
- Followed up in a case from the previous year in which a member was cited after a delivery driver to his home reported nudity to authorities; confirmed that charges being dropped as part of the pre-trial intervention and discussed related details; note that AANR had assisted this member with learning about counsel in the member's geographical location which was retained;
- Provided guidance to club reviewing and revising its bylaws concerning visitors, procedures, site usage, and complaints;

April 2021

- Provided guidance, case law, an expert Guardian Ad Litem opinion, and recordings of testimony before state senates from two different states concerning family nudism to be used by their counsel. This was given to parents whose custody was challenged after they brought minor children to two AANR clubs and a public nude recreation site within the state;
- Addressed questions about public nude beaches within the South to a board-certified attorney seeking to counsel his client about "do's and don'ts" given the client's past civil/domestic history with an ex-spouse;
- Provided guidance navigating club closures and sales prompted by events in real estate market(s);

May 2021

- Conducted various interviews with visitors to Hawaii nude beaches concerning their experience(s) on Maui (Little Beach) and the Big Island (Black Sand Beach),
- Provided guidance to a Canadian club concerning a member with possible criminal conviction;
- Assisted an AANR member (public employee) with case law, analysis, and information with which to supply their attorney concerning adverse action taken against their employment based on of participation in nude and clothing-optional activity during nonworking hours;
- Assisted with guidance to a club concerning the use of camera(s) to protect property on club grounds;

- Assisted a member with guidance concerning exercise in the nude within home occasionally observed by neighbors through window blinds;
- Assisted member in the South cited while mowing his lawn in the nude while on his own property in a remote location;
- Assisted a different member in the South who was observed briefly nude on his back porch;
- Assisted AANR member(s) with questions about enforcement/policies that require nude swimming in clubs;
- Assisted an education-related public employee and member denied future assignments after his employer learned of his advocacy efforts online on behalf of nudism; provided information about state-licensed attorneys in the field as well as possible steps within a union environment.

In July I expressed my remorse at not being able to join you for the convention. I am happy to be attending the Midwinter meeting and look forward to being at Suwanee Valley for Convention this year. Since July there has not been a lot of activities reported. Here are the reports from the regions covering their items of concern since July.

AANR F-GAT - Chair John Hunter

No items to report at this time.

AANR-Florida – Chair Jonathan Duffield

As this went to press on December 18th, there wasn't much news since our last report -- not very unusual since neither the House nor the Senate had been in regular session since April 30th of last year.

The Florida Legislative Session started early this year. It convened on January 11^{th} , will run for sixty consecutive days, and is scheduled to adjourn on March 11^{th} .

The pre-filed submissions included the usual range of "crackpot bills" characterized by being:

- A. overly broad,
- B. overly narrow,
- C. ambiguous,
- D. unenforceable,
- E. blatantly unconstitutional, or
- F. just plain goofy.

Such bills typically come from conservative lawmakers. But interestingly, a smattering of them have been introduced by liberal legislators this time around, so go figure. None of them are particularly threatening, however, and don't warrant much monitoring.

On a more positive note, Senator Jason Pizzo has once again filed a bill on our behalf. SB 176 would reinforce the protections afforded by Florida Statute 800.03 -- Florida's indecent exposure law. But as of this writing, we

were still seeking a Representative to sponsor its companion bill in the House.

More realistically, however, our project to *administratively* amend Florida Administrative Code Rule 62D -- the notorious state park swimming suit commandment -- is still on course and on schedule.

We strongly believe this is a much more reasonable approach to this initiative; and we are happy to report that progress *is* being made by our allstar legal team of lobbyist and political consultant Ramon Maury, former Lieutenant Governor Jeff Kottkamp, and AANR Executive Director Erich Schuttauf.

We have much optimism for achieving our goal this year, and *hope* to be able to report success by convention time next summer.

SUMMARIES OF SELECTED ISSUES Oklahoma Legislature

The second session of the 2021-2022 Oklahoma legislature will convene on February 7, 2022 and is scheduled to adjourn on May 27. To make the deadline for document distribution, this report has been prepared more than a month before the Oklahoma legislative session is called to order. No nudity-adverse legislation has been prefiled. Much can change in a month.

<u>Arkansas Legislature</u>

The short regular session of the Arkansas General Assembly will take place from February 14, 2022 to March 15, 2022. This is intended to be the state's

"fiscal session," with general legislation being saved for sessions in oddnumbered years. The relative brevity of this session will cause bill activity to be concentrated and intense. No nudity-related legislation has appeared by the time of this report deadline, but that can change.

Louisiana Legislature

The Louisiana legislature will convene March 14, 2022, and is scheduled to be completed by June 6 2022. Louisiana lawmakers are expected to consider more than 1,800 legislative bills in a period of less than two months. That's breathtaking pace.

<u>Texas Legislature</u>

Texas, with its multiple special sessions and its quorum-busting walkouts, was a legislative hot spot in 2021. Of note was the state's passage of a particularly stringent and much-discussed anti-abortion measure. That should give a fairly clear indication of the state's legislative temperament in its consideration of what it sees as a "moral issue." The Texas legislature will not meet in regular session in 2022.

special issues

 A lawsuit in Colorado challenging the criminalization of the uncovered chests of women had a peculiar effect in Oklahoma. A group of women sued the City of Ft Collins over its discriminatory ordinance that applied to women, but not to men. The women asked for an injunction preventing enforcement of the ordinance until the case was settled. A panel of the U.S. Tenth Circuit Court of Appeals allowed the injunction. But some erroneously believed that meant the women had won the case. Sensing defeat, the City of Ft Collins withdrew its opposition to the lawsuit and killed its ordinance. But not before the city council of Sand Springs, OK, passed a new ordinance of its own requiring that both women and men cover their breasts in public.

*In 2-year legislatures, all bills must pass their house of origin by the close of the first year's session, approximately mid-August 2021, or the bill automatically dies. Bills may be introduced the second year but must pass both houses during that legislative year. Special Sessions are the exception to the above calendar and may be called by the Governor of the State at any time to discuss specific topics.

Since my last report to the Trustees dated July 1, 2021, the following bills and news items of interest have occurred in the Western Region:

ARIZONA

No legislative or local issues of interest to Government Affairs has occurred since our last report.

CALIFORNIA

California 2021 SB 53. This bill would make it a crime for a person to knowingly send an unsolicited image by electronic means depicting any person engaging in an act of sexual intercourse, sodomy, oral copulation, sexual penetration, or masturbation or depicting the exposed genitals or anus of any person. The bill would make the crime punishable as an infraction by a fine of \$500 for a first offense and \$1,000 for a second or subsequent offense. We are opposed to the bill in its current form as it directly affects our nudist websites, publications, and sharing of images between members.

This bill is sponsored by Bumble and is supported by Feminist Majority and the California Women's Law Center. **AANR-West opposed the bill in its current form as it directly affects our nudist websites, publications, and sharing of images between members.**

After several committee hearings. the bill was finally put in the inactive file by its author in mid-June, meaning it is dead for this year.

California 2021 AB 307 Covers the same territory as SB 53 but focuses on lewd intent when images are distributed, and it requires registration as a sex offender if the person is convicted. No committee hearing date had been set yet, meaning it may also be dead. We are watching it.

In Other California News of Interest...

Activist March For Topless Equality In Fort Bragg, CA

Local top freedom activists stages a protest rally on July 28 to support a change in the local city ordinance that gives men different rights than women. An estimated 25 women participated, many in festive body paint, feathers, and body jewelry. Several had slogans painted across their chests, such as "My Boobs are Legal!" and "Freedom!"

Protesters said the rally was in support of Marie Willa Bobo-Smith, 57, a local transgender woman. Bobo-Smith addressed the crowd at one point, stating: "Since I was a kid, I have always walked through town without a shirt for health reasons. Nobody cared. Suddenly, since my transition, I am the target of hate mail and phone calls, and it is very hurtful. This inequality isn't fair."

The protest group proceeded to march through downtown which was busy at the time with an influx of summer tourists. The marchers walked on the sidewalk waving and carrying signs that said, "I am with her," "Equality has no gender," and "You have boobs too!" Rally organizers said the onlookers cheered. No comment from city officials.

The town of Fort Bragg is a quiet little town of 7,000 on California's Mendocino Coast It should not be confused with the larger Army base of the same name in North Carolina.

Carpinteria's Bates Beach

On Sunday, 8/22 a deputy sheriff cited a man for public nudity who was NOT in the approved clothing-optional area at the far western end of the seawall. He was only half way there and decided that was far enough – surprise! This is the first citation written on Bates since 2008. It's also the reason we moved farther down the beach to the north end of the seawall to avoid any complaints and user conflicts. It was the talk of the day among the other 40 nudists enjoyed the beautiful summer afternoon.

As a result, Gary Mussell had to make several appointments with officials in the city to make sure everyone was still cool with the verbal agreement allowing the nudists to remain on the beach, and they were.

Friends of Bates Beach also reached an agreement with Aaron Hunter of UC Santa Barbara (nearby) who has a grant to measure sea level changes by measuring the changes in the width of the beach sand on Bates Beach for the next several years. This data will be added to the statewide beach monitoring project to help to measure local climate change.

On Saturday, September 25, the SCNA club and Friends of Bates Beach coordinated the cleanup of Bates Beach as part of the annual California Coastal Cleanup Day. Coastal Cleanup Day happens each year on the third Saturday in September. Beaches up and down the California coast were also cleaned up. About 90 pounds of trash and 12 pounds of recyclable material was eventually collected from our area. In Santa Barbara County, over 1,287 volunteers at 28 sites cleaned up 6,104 pounds (or 3.05 tons) of waste.

Nineteen club volunteers picked up trash and recyclables for three hours along the 2.5-mile beach, the parking lot, and the hiking trail above. We were joined by twelve volunteer students from the nearby Cate Private Boarding School. This was the first time that Cate has sent volunteers, and the teens seemed to really enjoy participating.

The Bates park ranger, Alex Contreras, dropped by at the end of the cleanup to collect the trash and to meet many of the Friends of Bates volunteers for the first time.

For the second straight year, Carpinteria's Avocado Festival, scheduled for October 3-4, was cancelled until 2022 due to the rise in COVID-19 cases in the County. We have staffed an information booth at the Festival for the past several years and always received a great reception from the local community. Usually about 70,000 people attend the two-day free festival.

November 15, 2021 - AANR-West Board has decided not to financially underwrite the continuing efforts of the Bates Beach clothing-optional beach. The local Friends group will seek other sources of revenue.

Auburn Dam State Park General Plan Hearings

The California State Parks Commission held a public online hearing September 29-30 to review the General Plan Update for the Auburn Dam Recreation Area located along the North Fork of the American River, about 50 miles northwest of Sacramento. The Commission members were also asked to approve the Plan's underlying Environmental Impact Report.

This update directly affects the traditional nude beach that is located just below the dam.

Gary Mussell, AANR-West Gat Chair, spoke via ZOOM to the hearing. Here is a copy of his remarks:

"We have spoken to you at many past meetings of the Commission, about reaching an understanding on how to accommodate all the Californians that enjoy clothing-optional recreation. Several thousand underdressed beachgoers and hikers are out there in the state parks every weekend, and they are not going away.

"Several years ago, the Parks Forward Commission asked us to put together a written proposal on how to resolve this never-ending request, and we did so. But they chose to defer our ideas to the Parks Commission, which is you.

"The Auburn Dam report mentions nude recreation 23 times across its text. All of them defer to the California Code of Regulations Section 4322 which states:

"No person shall appear nude while in any unit except in authorized areas <u>set aside for that purpose</u> by the Department."

"So, you do not need new legislation to resolve this issue. The CCR gives your commission that power. We ask for you to amend the report and retain the small beach below the Auburn Dam as an authorized clothingoptional area within the park. The Recreation Area cumulatively has hundreds of miles of waterways and hiking trails, and we are asking for a thousand feet in an area where it has existed peacefully for over fifty years. We ask for proper signage at entrances to the area to help avoid user conflict.

"I would remind the Commission there is no federal law or regulation against nude recreation.

"Please revise the report by doing your duty and officially designate the area."

Tim Mullins, AANR GAT Chair, submitted a written statement as he had trouble connecting into the meeting to speak:

"My name is Tim Mullins, I am a lifelong Californian, and enjoy and use the American River Canyon area.

"I am also the Government Affairs Chair for the American Association for Nude Recreation. We have participated from the beginning in this General Planning process. We have submitted our requests for specific use areas on numerous occasions.

"From the beginning we have asked that you, "Please recognize and provide for clothing-optional use in areas where clothing-optional use has long been traditional."

"We are disappointed in the lack of serious consideration for our requests in this Plan. By comparison, in Florida, the request for nude use areas has resulted in inclusion of our advocates in the planning process and a financial boom to the areas where they have designated nude use areas. California should be able to designate nude use areas within the proposal and meet the needs of those of us who prefer to use these areas safely."



The General Plan Update has been controversial from the start. Although the existing Plan is 30 years old and in need of review, community leaders expressed concerns through all the hearings about the Park Department's desire to expand the number of campsites from 36 to 135.

All of the other public speakers spoke to oppose this campsite increase due to increased fire danger and changes to the traffic

infrastructure from additional traffic.

Despite objections from local County Supervisors as well as CalFire's objections, the commission voted 5 to 0 to accept the draft Plan.

COLORADO

After a brief truce, the nudity crackdown by deputies at Little Beach on Maui and Kahena State Beach came back in July 2021, with tickets issued aggressively by state park deputies. The message seems clear: Kurt Cottrell, the superintendent for the Dept of Land and Natural Resources (DNLR) is intent on shutting down all nudity in all the state parks.

On June 23, he led a public discussion on the future of outdoor recreation education in Hawaii. It became a forum for his ideas on "the respectful use of outdoor spaces...and the ongoing challenges of communicating with recreationalists." Meaning us.

Bill Watts and other directors of the newly formed Friends of Little Beach set up a 501(c)(3) nonprofit corporation and it became official a month ago. Watts wrote us it may take up to a year to get IRS approval for donations to be deductible, which is typical. Meanwhile, AANR urged them to quickly build a new website where people can donate to a GoFundMe page. The website at <u>www.littlebeachmaui.org</u> went live in October.

Donna Dowling of the Friends of Little Beach emails us to say their startup costs accrued over the past six months were paid for from \$3,000 in loans by the core team members. The funds were needed to pay "for professional fees and costs: attorney, web design and hosting, accounting, P.O. Box, business cards, and other supplies."

In August 2021, Bill Watts wrote to us to say there are 11 active citations still pending, three issues recently.

"The prior cases...issued in the March-May time frame were all lost as the judge rejected any defense arguments and even quotes the public prosecutor's argument in his judgments."

Bill said many of those with tickets have decided to just pay the \$100 ticket and \$30 court fee and accept six month's probations "because after six months with no repeat offense their records are wiped clean." The alternative is a trial where they can be found guilty of indecent exposure, which now goes on their permanent record.

Bill wrote we has been in touch with State Rep. Tina Wildberger (District 11), who represents the area. He says she is on our side and "disgusted with the responses she has received from the DLNR." She held a ZOOM meeting with Friends of Little Beach (FOLB) directors on July 21. She is working on a bill to present in the House but agreed it would not go anywhere because so many representatives are of plantation and missionary mentality.

On November 22, Gary Mussell wrote to Bill Watts and Representative Wildberger:

"I would like to see what Tina's bill says also. A bill just allowing nudity at Little Beach means no nudity anywhere else in the state and I have a problem with that. If there is to be a bill amending Parks Procedures and the powers of the Director without a hearing, that might do the best. We want to curtail the arbitrary power of the DLNR so that should be our focus.

"No legislator should ever be asked to support "nudity" as in their eyes it the same as asking them to be accused of supporting "sex perverts" and to be defeated next election primary, as their opponents will obviously say. Hawaii does not have contested elections, so the danger is being "primaried" within their own party.

"Perhaps if the bill is tabled without a hearing would be a strategy by Rep Wildberger as it would give legislators on the policy committee a chance to not be on the record, but we could gauge silent support from their staffs (where the real power lies). My rule from years in politics: Always count your votes before introducing a bill unless you just want to martyr yourself "on principle." Publicly losing at this stage will only embolden our opponents to take further actions against other beaches. We have to build our case and that will take time, maybe a few years."

Kehena Beach on the Big Island Is Also Under Attack



Background: Kehena Beach on the Big Island has been traditionally clothingoptional for decades.

Because of recent volcanic activity at nearby Kīlauea, lava has overtaken other beaches leaving Kehena Beach as the only accessible spot on the Puna coastline.

Since last year the beach is attracting large crowds, both nude and textile, making social distancing difficult.

Since late March, more than 100 citations have been issued there for violations ranging from marijuana possession and "public lewdness" (i.e. public nudity.)

Rangers are citing the state parks law against nudity even though Kehena Beach is not a state park. Law enforcement officers <u>told *West Hawaii Today*</u> in April they did sweeps of the beach to enforce mask-wearing where parties could not safely keep 6 feet apart. Cars parked along Highway 137 near the beach were also cited for minor traffic issues. However, since mandatory mask wearing in open spaces is no longer required, the ticketing has continued.

Curt Cottrell, state park administrator, has made several anti-nudity remarks on local news stations it is obvious to all he will ignore the public survey results that shows public support for nude recreation in the state and continue his mission to ban nudity statewide unless he is stopped by the courts or the legislature.

Fires Situation Eases Around Lake Tahoe But Problems Remain

September 23, 2021 - The state closed all beaches around Lake Tahoe due to the fire danger and the unsafe air until Sept. 18.

When we got back, we discovered that some of our members' personal beach equipment, which had been locked up, had been was removed by the Forest Service when they shut down the area. No advanced notice was given, and nobody was able to get down past the closure to retrieve their items. At this writing some of our club beach equipment is still unretrievable.

"The summer season at **Creek Beach** was much different than in previous years because the lake water level was so much lower. We had a nice quiet beach experience until the smoke came.

The Cove was another story. Our nudist weekends were overrun with textiles. Why? Because the Nevada State Parks decided to limit attendance and vehicles at nearby **Sand Harbor**. This had nothing to do with COVID, but rather it was an arbitrary maximum occupancy number decided to control the number of people at Incline Village resort. In 2020, this maximum was extended to all local beaches. As a result, those tourists just come on down the road to use the next available beach – our Cove. They parked illegally anywhere and everywhere, left trash and graffiti and complained about the naturists already there. We contacted the Nevada State Parks and got the usual government responses: "we are trying to save the lake." Excellent job, guys! We will be working on this in the off season, and plan to start contacting elected officials about this egregious situation.

The nudists at **Creek Beach** did not suffer as much as they are a half-mile further down the shore, and this beach is not as easy to get to.

Enforcement of forest rules at all the beaches was non-existent all year by the Forest Service and by the Carson City Sheriff. Servicing the trash and outhouse was farmed out to vendors, and the sheriff wasn't paid for the foot patrol, so nobody was there, and the trash cans were left overflowing. The mandatory beach closures during the fire weren't enforced as far as we could determine.

Our main issue at **Cove Beach** continues to be from the gay couples who can't seem to keep their hands off each other while there. I have Warning Cards printed up that I hand out to anyone I suspect is misbehaving sexually while nude on the beach, and they are effective. But I can't always be there.

Our concern is this activity will give the sheriff the excuse he needs to shut the nude beach down.

As we approach October, we do have a few more weeks in our season before the temperatures drop and the snows come. We are using this time to removing graffiti from the rocks and to make other repairs now that the threat of fire has passed for the moment.

NEW MEXICO

Tico Time All Night Long!

In June we saw an article about a nudity complaint in Aztec, New Mexico that caught our attention. It seems the Tico Time River RV Park, near the Colorado border, enjoys hosting weekend music festivals and the drunken revelries, drumming, and other loud activities by the young people attracted to them are annoying the nearby residences. Complaints of drug use and skinny dipping at the campsites are among the complaints filed with the county manager and local sheriff. However, in that rural area, there currently are no zoning codes, noise ordinances or many other government regulations. The local television station carried the story:

Bottom line is that people moved there over the years precisely because there aren't any regulations, and they like it that way. They just want the RV Park to have more consideration for its neighbors. Apparently the park has volunteered to impose a noise curfew so the problem is solved, at least for the moment. Since there will be no new rules against nudity (or anything else), GAT no longer has an interest in the outcome.

Santa Fe National Forest Renews Ban on Nudity.

Over the summer, Matthew Reisen in The Albuquerque Journal reported the Santa Fe National Forest has renewed an order banning nudity, underage drinking, and extended camping within the forest boundaries. The hot springs in the Jemez Mountains (center/north part of the state) seem to attract more people in the buff, says Reisen.

SFNF spokeswoman Julie Anne Overton said there has not been "any kind of increase" in nudity or underage drinking. This renewal of the regulation "is kind of a routine thing." She is quoted as saying they renew the order every time it expires to give authorities the right to ticket those caught in their birthday suit, youngsters knocking back cold ones and campers who wear out their welcome — specifically, the order prohibits camping for more than 14 days, consecutively or not, within a 45-day period. Violators can be fined up to \$5,000 while organizations can be fined up to \$10,000, spend six months in jail, or both. The order lasts until December 2026, when it will again be up for renewal.

GAT spoke to local nudists in the area who agreed this renewal is a routine thing, as the ban has been renewed several times in the past. Still, GAT will remain vigilant watching for innocent nudists who wander into the banned areas without knowing the regulations.

All regional presidents are invited to these meetings and receive reports and announcements. A special thanks to Donna Jennings, NW President, for her consistent attendance and note taking.

Many thanks are due to many contributors, especially to George Oberle in getting the new AANR.com website launched. This website is much more attractive and is now responsive to cell phones and other devices that it is being viewed on. One notable and essential feature is its ease in adding new content. While there is currently an adequate supply of material, we need to identify ways to bring in new or guest contributors.

With our electronic presence greatly improved, we should follow up on other earlier recommendations: a) promoting and advertising naturist businesses which would be mutually beneficial in terms of revenue and educating the public; b) reaching out to the existing Twitter users, Naturist Bloggers and Instagram

users who may be interested in affiliating with AANR; c) supporting AANR influencers who will drive visitors to our site, and d) republishing Bulletin articles edited for public view.

Naturist Hub has officially been identified as AANR's approved social media site. George Oberle reports that it has gained a tremendous number of followers both nationally and internationally.

The first of the AANR SIGS (Special Interest Groups) focused on photography. The attendees were interested in a follow up meeting for more technical online training. A Google group was created, an online course is being selected and they will meet to share what they have learned. The second and third SIGs will be a Ham Radio Meetup and a SIGs for those parties that use Social Media for AANR or club related marketing.

A bylaw change was proposed by the M&M and PR Committees to substitute the term *Associate* to *Direct Member* to refer to members who join AANR directly rather than through a club. Although to some, it may not seem to be an issue of concern, words do matter. This change aims to emphasize the importance and equal value of these direct members who make up over 41% of AANR. With less than three weeks before the deadline for final bylaw wording changes, the office unexpectedly determined that this change would incur a huge expense. As of this writing, the committee chairs were working to understand and mitigate these costs as the deadline neared.

At the summer board meeting, the board recommended that the committees evaluate proposing changing the terms *landed* and *non-landed* clubs to terminology that was more recognizable to those outside of the organization. The committees' members voted to not pursue these changes.

New professionally-developed, social advertising video clips regarding the benefits of nude recreation have been created for the Florida region, using an AANR Educational Foundation grant. These will be disseminated widely through social media and businesses. Templates will be made available to regions and clubs and can be altered/adapted to suit different needs. Changes may incur minimal cost unless undertaken by individuals with appropriate expertise. At present, these preliminary designs have been sent to M&M and PR members for their feedback re what they feel would meet the needs of their region, clubs and members.

Another project in serious discussion is the development of an AANR newsletter that will be sent to all members. It will allow members to interact electronically to ask questions and get replies and to function similarly for AANR. It will include important information from all of the regions, show regional cohesiveness and fill the niche between the Bulletin, Undresses Press and Weekly Reports. Participation of regional presidents and/or their PR representative or team will be essential for timely reporting of events, club features or nudist-friendly spots in their regions.

The Youth and Diversity Committee, which has been headed up successfully for several years by Timothy Sargent, will have new leadership in 2022. Mariya Atkinson and Scott Pierobon from Western Canada and Jason (Jay) Summers from AANR-East are three young adults who have demonstrated enthusiasm, skill and a cultural perspective that will contribute greatly to AANR's goals. While Timothy plans to pursue new avenues, he has created the AANR leadership survey that was forwarded to staff and officials. These results will be tallied and shared as consolidated data to show the values underlying AANR's mission.

The Social Media Guidelines that were approved by the AANR Board and that outline appropriate professional communication in all media and materials have been sent to all the regions and have been placed online.

The 90th AANRversary was celebrated by many clubs who submitted pictures to the Bulletin showing a variety of creative ways that they acknowledged this milestone in AANR's history. A series of articles showcasing significant people and events over decades was published in the Bulletin. Our next major milestone is our 100th AANRversary and we have agreed to get an early start planning for this event.

Mary Jane Kolassa. AANR's media consultant, continues to pitch to various news media to apprise them of AANR's initiatives and to spark interest in their writing about us. Her monthly reports demonstrate the wide range of her outreach.

| Details: | The investment balances as of December 12, 2021 were: \$21,000 available for immediate loans and about \$131,000 available from the Miller Investment Fund in Raymond James, if needed for additional loans. There are sufficient funds in the accounts available for loan to give a number of \$5,000 to 10,000 loans to clubs that are interested and qualify. Only about \$105,000 of the fund is restricted to investment only. The funds will recycle as loans are paid back on up to a five year time frame. Thanks to the committee volunteers. |

During the last 6 months I have worked with AANR members around the US as well as in Florida working with clubs and members to renew and increase our membership.

I have worked with the AANR office regarding clubs that need to get with the program or not be AANR clubs. If they want to have free advertising thru the AANR website as well as the List of Clubs brochure, they should offer AANR discounts as well as have AANR logo on their website. The Finance Committee, in accordance with the Association's ruling documents, is composed of President Kathy Watzel, Secretary/Treasurer Kathy Smith, Chair of the Planning Committee BG Parkes, Executive Director Erich Schuttauf, and Chair of the Finance Committee Alan Harris. The Finance Committee met as the Budget Committee at the AANR office and via Zoom in early December. Judy Mason, the Association's Director of Finance, participated in the meeting and updated budget worksheets as the discussion progressed. Max Schuttauf handled the Zoom set-up and other electronic issues.

The budget income statement is attached as a pdf file. The first column is the full year budget for 2021 as distributed on January 6, 2021. The second column is actual results for the ten months through October 31, 2021. The third column is the best estimate of what actual results for 2021 will be. If no additional revenue or cost was expected in November or December, the forecasted amount in column three is equal to the actual results through October in column two. If additional revenue or costs were expected in the last two months of the year, column three is the estimate of what the yearly total for 2021 will be.

Column four is the Budget Committee's consensus estimate of 2022 revenue and cost. The last column is the difference between column three, the estimate of 2021 final results, and column four, the 2022 budget. All amounts in column five that are not in parentheses are those that improve estimated results for 2022 over 2021. All amounts in parentheses are those that make 2022 estimated results less than those estimated for 2021.

The final results on the last page show a budgeted net income for the Association in 2022 of \$1,593. This is \$198,961 less than the current best guess for 2021 final net income of \$200,554.

Everyone on the Committee had gone through this exercise before, and for most of us multiple times, and every revenue and cost line was discussed. All amounts for the 2022 budget were reached by consensus and represent awareness of Association history, current membership numbers and current costs. In all cases where there cannot be more than an artful estimate, amounts shown are conservative i.e. lower for revenues and higher for costs.

The Committee felt that it faced even more unknowns than in recent years. For example, the looming Covid pandemic was unknown when the 2020 budget was prepared. Vaccines were almost ready to roll out when the 2021 budget was prepared and there was optimism in the scientific world that these would soon result in herd immunity. Would that that had been the case.

This year the issues included when or even whether the Covid pandemic will subside in 2022 given the millions of people who have chosen to remain unvaccinated (it should be noted that the extreme transmissibility of the omicron variant was not yet widely known in early December); whether warm weather clubs can or will open and what the effect on membership will be; what the effect of inflation will be on many costs; and what will happen to the economy, and therefore the Association's investment returns, as the Federal Reserve soon starts to take steps to curb inflation.

These are details on several material lines of revenue and expense:

Membership: The committee reviewed recent membership totals and basically made 2022 estimates about equal to where 2021 amounts are expected to be. The effect of the resurgence of Covid makes any changes in membership revenues a total guess. On the one hand the omicron variant is much more transmissible (the US set a new record of over a million cases yesterday), but on the other hand the omicron cases appear to be less debilitating. There is no good way of estimating how many members will choose not to visit clubs because they are not comfortable with possible COVID-19 exposure and choose to let their membership lapse as was widespread in 2020.

Trustees Committees & Officers: Election expenses of \$30,000 are estimated for 2022 and there is no similar expense in 2021. As was mentioned in the 2021Q3 analysis, this bi-annual cost is going to be accrued ratably monthly starting in August 2022 so that the estimated cost for the 2024 election will be fully accrued by July 2024 and each election thereafter will be similarly fully accrued.

Restricted Funds: The committee budgeted \$28,600 of net income for the year. As always this is very conservative and it's hoped that actual results will be considerably better. Markets could truly go either way, given Covid and imminent Fed tightening of the money supply.

Please direct any questions to myself and Judy Mason in time to do any necessary research before the mid-winter meeting in February. Questions and answers will be shared with the larger group as they are received and researched.

| RE: | Research on the size and composition of the Legislation Committee |

After the convention this summer, I reached out to the National Association of Parliamentarians and asked their research team (listed at the end of this report) to clarify whether or not the Legislation Committee should be a single person. They responded with answers to two issues, which I wish to discuss (educate) in this white paper.

First is the issue of whether a committee composed of one person can make a motion from the committee without the need for a second. Robert's Rules of Order, 12^{th} Edition, Section 50:1 states that "a committee is a body of one or more persons." It also states in Section 4:11 "a motion made by . . . a duly appointed committee of the assembly requires no second from the floor (provided the subordinate group is composed of more than one person)" In my opinion, what this says is that it is not appropriate to have one person committees if/when the committee wants to make a motion in a meeting.

The second issue is one of whether the Legislation Committee should be a single person. Robert's Rules of Order, Section 56:4 states, "a committee to draw up proposed bylaws should generally be large, and should include the most judicious persons available, those who have a special interest in the rules of the society and those who would otherwise be likely to consume much time in discussing the bylaws when they come before the assembly for adoption." Section 56:5 even suggests that the committee should consult an attorney.

NOTE: Robert's Rules (AKA RONR) does not differentiate among bylaws, constitution, governance manual, procedure manual, policies or any other ruling document. It uses the term "bylaws" inclusively, so when it says "Bylaws Committee," the reference is to what AANR chooses to call "Legislation Committee."

NOTE: AANR Bylaws Section III Article X, Paragraph D, states that Robert's Rules of Order is one of the AANR Ruling Documents and should, therefore, be followed.

I have consulted the following Professional Registered Parliamentarians for their assistance with the committee work for the Research and Education Committee: Joe Neglia, Ann Homer, Rachel Glanstein, Azella Collins and Timothy Wynn. Robert's Rules of Order, Section 13:15 states "a standing or special committee may include . . . one or more persons who are not member of the assembly or the society. . ." It is, therefore, acceptable to request assistance from these PRPs.s

Midwinter Trustees' Meeting 2022

MOTION: I move to amend Governance Manual Section 8.01.00 by adding a new subsection 8.01.20 as follows (and renumbering the remaining three subsections):

- 8.01.20 Bev Price Award. This award is given to the person (or persons) who creatively sustains a nudist/naturist event outside a traditional nudist location for a period of no less than five years.
 - 1. The five years do not have to be consecutive, but the event must be the same type of event each of the five or more years.
 - 2. The event must take place in a public setting that is not designated as nudist/naturist.
 - 3. The award is at the discretion of the AANR office and will be funded by AANR.

PURPOSE: To recognize leaders who creatively sponsor events for nudists over a sustained period of time.

FISCAL IMPACT: The annual cost of the award.

and to amend the Biography section of the Official Forms document by inserting the following in the proper alphabetical order:

A Biography of BEVERLY B. [BEV] PRICE

The Bev Price Award is given to the person (or persons) who sustains a nudist/naturist event outside a traditional nudist location for a period of no less than five years. The motivation behind the award was the nude Grand Canyon Raft Trips that Bev planned and executed from 1999 until 2021.

Bev has been an ASA/AANR member since 1972, and in 1980, Bev helped found the Arizona Wildflowers, a traveling nudist club headquartered in the Phoenix area. The membership of the Wildflowers has varied from just under 100 to well over 250. Bev planned and executed the various activities, including both house parties and forays into public areas. These included houseboating on Lake Powell or Lake Mead and rafting both Cataract Canyon and the Grand Canyon with both members of the Wildflowers and their guests.

Bev was active in WSA/AANR West beginning in 1983, serving at various times as Director, Secretary, Treasurer and President. At the same time she volunteered as Delegate Credentials Chair and Legislation Chair for ASA/AANR. She was also appointed to the AANR Education Foundation and served as its President for several years.

In 2014 Bev was elected to the office of President of AANR and served two terms in that role. During that time the AANR office in Kissimmee, Florida, was completely renovated. In 2018, Bev was elected to the position of AANR Trustee and served additional years in that position.
